No Refunds!**

This is **Not** an AAU Sanctioned Tournament

All games will be played at Huntington High School and Phil Cline Center YMCA

**ALL COACHES, PLAYERS AND PARENTS WILL CONDUCT THEMSELVES IN A SPORTSMAN LIKE MANNER!!!**

1. **Length of Games:** **RUNNING CLOCK** 20 minute halves, will run like normal in last 2 min
2. **Entry Fees:** \$200/team (non-refundable AFTER tipoff of 1<sup>st</sup> game), 3 games guaranteed.
3. **Overtime:** Will be 3 minutes; each additional quarter will be 1 minute in length.
4. **Timeouts:** Each team allowed 2 full timeouts per half.
5. **Running Clock:** The clock shall run continuous in the second half when a team has a 20pt lead. It will only stop for injuries or timeouts. The clock shall become normal once the lead is decreased to 15 pts.
6. **Pressing:** No pressing will be allowed once a team has a 20pt lead. If a team has a 20pt lead they must retreat to a half court defense until the lead is less than 20pts. **There is no press rule for age groups 6<sup>th</sup>-12<sup>th</sup>**
7. **Game Ball:** The home team will supply the game ball.
8. **Game Jersey:** The home team will wear light jersey.
9. **Format:** Pool play with seeding to follow. You will be seeded based on your results of your pool play for a single elimination bracket to declare a champion.
10. **Every effort:** Will be made to start each game on time. If there is a delay please be patient. Pre –game warm up time will be at least 5 minutes. Halftime will be 3 minutes. Arrive at least 30 minutes before scheduled game time.
11. **Outside Food & Drinks will not be allowed in the buildings. This goes for coaches, players, parents and all fans. There will be a concession area.**
12. I/We assume ALL risk and hazards incidental to such participation. I/We do hereby waive, release, absolve, indemnify and agree to hold harmless the D-1 Greyhounds Basketball Program, its coaches, administrators and players, Huntington High School, Phil Cline Center YMCA, or the Cabell County Board of Education.
13. **Absolutely no harassment or badgering of officials will be allowed.** Coaches are asked to speak to their players and fans about this matter prior to each game. Players will be assessed technical fouls for such actions. Fans will be asked to leave the premises. If coaches cannot control their fans and/or players, the games will be forfeited. Any player ejected from the game due to a flagrant foul or unsportsmanlike conduct is subject to tournament suspension.

***The decisions of the referees are final and binding!!!***

**All teams MUST have use AAU legal ages players playing in their age bracket unless the age of a player is preapproved by tournament director. Any team who violates this rule will be out of the tournament and their games forfeited and no refund of their entry fee. This decision will be made by the tournament committee and the decision is final!
