TOURNAMENT RULES

Normal High School rules unless otherwise noted. Each Player is allowed (six) 6 fouls per game.

Home team: First team listed or top team in bracket play
Wear light jerseys
Sit on the left side of the scorer's table
Warm-up at the opposite end of the court

Visiting team: Second team listed or bottom team in bracket play
Wear dark jerseys
Sit on the right side of the scorer's table
Warm-up at the opposite end of the court

**EACH TEAM PROVIDES A
SCOREKEEPER/CLOCK OPERATOR
*3 COACHES BANDS PER TEAM***

***Additional Coaches Bands can be purchased for \$25**

Game Length:

Divisions – 7TH thru 8th Grade Boys

- Three Minute Warm Up
- **(2) Sixteen Minute Halves**
- Two Minute Halftime
- **No One & One, 2 shots on the 10th Foul**

Divisions – 5th & 6th Boys

- Three Minute Warm Up
- **(2) fourteen Minute Halves**
- Two Minute Halftime
- **No One & One, 2 shots on the 10th Foul**

Divisions – 2nd – 4th Boys

- Three Minute Warm Up
- **(2) 12 Minute Halves**
- Two Minute Halftime
- **No One & One, 2 shots on the 10th Foul**

Ball Size:	Boys 8U-12U	28.5
	Boys 13U-14U	29.5

- Time outs per game:
Four (4) time outs per Game. 1 TO can carry over.
One (1) additional 30 second time out for each overtime period. 2 min OT
- **Mercy Rule:** If a team gains a lead of 20 or more points, the clock will run. When the score difference is back under 15, the clock will begin to stop on every whistle.

Teams provide own balls.

Tie Breaker for Pool Play

Two (2) teams tied – head to head competition

Three (3) teams tied – points involving those three (3) teams only

Four (4) teams tied – points involving all four (4) teams

Maximum points for a win or a loss is 15 points

Example: Team Red 64 – Team Blue 32
Team Red +15 Team Blue -15

Protests:

A protest should be reported immediately so that it may be heard in a timely manner. Any protest of player eligibility must be made **prior to a game**. Failure to protest eligibility prior to a game will waive a team's opportunity to protest any player's eligibility for that game.

All protests must be in writing and accompanied by the official protest fee of \$50 cash. This fee is refundable only if the matter is ruled in the favor of the protesting party. **The ruling on a protest**

will be made by the Tournament Director and is final and binding on all participants in the event.

****NO Protest after Pool Play. Player must compete in at least 1 Pool Game to participate in Bracket play.**

Coaches:

Must have First and Last name of ALL Players filled out on ALL score sheets for each Pool Game.
