Age Groups:

- 8u, 9u, 10u, 11u, 12u, 13u, 14u (60/90) and 15U
- "Elite" level teams are expected to play up an age group (determined by tournament director)

Format:

- 4 game guarantee
- Tournament is limited to 8 teams per age group (2 four-team pools)
- Three-game pool play (1st pool play game on either Thursday or Friday; 2 pool play games on Saturday)
- Top 2 in each pool advance to semi-finals on Sunday; eliminated teams to 1 consolation game (Sunday)
- Awards to 1st and 2nd place in each age group

Entry Fee:

- Entry Fee: 8U-10U \$400; 11U-15U \$450 (\$25 discount per team for multiple team programs)
- Baseballs/umpire fees included (1 certified umpire 8U-10U; 2 certified umpires 11U and above)

- Notre Dame Elementary
- Munson Township Park
- Claridon Township Park

Refund Policy:

- 0 games played – 75%; 1 game played – 50%; 2, 3 or 4 games played – 0%

Get your registration in early with payment in order to hold your spot. Entries will be accepted on a first come, first paid basis.
