COVID-19 Guidelines and Release and Assumption of Risk

COVID-19

The Revolution Classic will follow the 2020 School and Youth Sports Reopening Guidelines published by WellSpan Sports Medicine, which are attached to this release. Please note the following specific points.

- Strict 6-foot distancing must be maintained except when actively on the field of play.
 - Only the players in the active lineup will be in the dugout, and must still maintain 6-foot distancing.
 - Players not in the active lineup will sit in marked seats behind the dugout and enter the dugout only if/when inserted into the lineup.
- All players must wear a mask when not in a seat or on the field of play, and as further directed by the event operators.
- No equipment may be shared – each player must use his/her own bat, glove, etc.
- Players must provide own water bottle/beverages.
- No seeds or gum may be chewed.

Athletic Competition

I understand that baseball games are inherently dangerous, and I assume the risk associated with such contests.

Release and Assumption of Risk

I understand that I am signing this release as a condition to and in consideration of my participating (or the participation of my child/ward) in the “Revolution Classics” at PeoplesBank Park, ballpark of the York Revolution and owned by the York County Industrial Development Authority.

I hereby represent that I am at least 18 years of age, physically fit and of sound mind and body, and capable of giving this release for myself or for my child/ward under the age of 18.

I have read and understand the 2020 School and Youth Sports Reopening Guidelines published by WellSpan Sports Medicine. I understand the specific provisions highlighted above in this agreement, and I agree to abide by them. Further, I agree to monitor my (or my child/ward's) health and not participate in this event if my temperature is over 100 degrees or I exhibit any of the symptoms of COVID-19.

Therefore, for good and valuable consideration, receipt of which is hereby acknowledged, I fully and forever release and discharge York Professional Baseball Club, LLC, PeoplesBank Park, and the York County Industrial Development Authority and their respective members, officers, directors and employees, all participating sponsors, their parent and subsidiary corporations, any business entities in which they may have any ownership or management interest, and all persons acting by, through, under or in concert with them or any of them (hereinafter individually and collectively referred to as “Released Parties”), from any and all liability or claims of any nature and of ever and kind whatsoever, known or unknown, suspected, fixed or contingent, including, without limitation, liability from the

negligence of the Released Parties, that I may have in the future, in connection with of resulting from my participation in the Revolution Classics at PeoplesBank Park.

This signed statement shall serve as a release of assumption of risk for me, my heirs, executors, assigns, and any business entities in which I may have any ownership or management interest, and in the event of my signature on behalf of my child/ward, the release of my child's parents, guardians, legal representatives, heirs, executors, and assigns. I understand that baseball and softball games are inherently dangerous, and I assume the risk associated with such contests.

I also hereby agree to:
