

### **ARRIVAL & CHECK-IN PROCESS**

- All teams will be assigned an arrival time. It is important to be on time! Arrival times and location, as well as facility maps will be released later in the week.
- All players, coaches, and any others MUST CHECK IN TOGETHER. If someone is missing from the team, the team must wait to check in.
- If a parent and player are going to both be present in the facility, they must check in together.
- A member of the HDN staff will
  - o check to ensure each participant has a completed waiver form, found here.
  - o ask if the participant, or anyone in their family, has had a cough, sore throat, fever, shortness of breath, or been exposed to anyone with Covid-19.
  - Take each participant's temperature
  - Ensure that all keys, phones, water bottles, basketballs (2 MAX PER TEAM), and hands are thoroughly sanitized.
- Teams will choose their team area. This will be a space where they will sit for games, and in between games, if applicable. TEAMS WILL NOT SWITCH BENCHES FOR GAMES TO REDUCE CROSS-CONTAMINATION.

# WAIVER, POLICIES, & CONTACT TRACING FORM

- Every person who is present in our gyms must have a Waiver, Policies, & Contact Tracing Form completed prior to entering.

# **TEAM/GROUP SIZE BY LOCATION**

- We are limited by Department of Health Orders and the individual policies for each facility.
- Sport Stable: No Spectators. Only 16 PEOPLE PER TEAM MAXIMUM will be allowed in the Stable. This is non-negotiable.
- Parker Field House: Only 23 PEOPLE PER TEAM MAXIMUM will be allowed in the Parker Field House. This is non-negotiable.
- All teams must provide ONLY ONE designated scorekeeper for all 3 games.
- Once a participant (player, coach, parent, ref, etc.) is in the facility, they will not be allowed to leave and re-enter the facility.
- All people with each team must have a Waiver, Policy, and Contact Tracing form filled out and must check in together.
- All adults must check in with their child.
- All people with a team must stay within the team area. This is to minimize cross-contamination and reduce chances for exposure and spread.



#### LIVE STREAMING INFO

- All games on all 3 courts at the Sport Stable will be streamed live via PlaySight.
- The day pass is \$4.99 and the log-in for your day pass can be given to other family members like grandparents who would like to watch also.
- Game film can be purchased as well after the fact.
- Games at Parker Field House will not be live streamed.

### **SCHEDULE NOTES**

- We have scheduled games in a way that we normally would not. Games are scheduled with the following priorities in mind:
  - Reduce exposure across divisions so that we can contain any exposure and spread should we have a positive case. If someone tests positive in one division and there were two divisions in the gym, then all teams in both divisions will be asked to quarantine.
  - Reduce time at the gym, which also means reducing chance for exposure and spread.
- Several teams are scheduled for 3 games in a row. We have scheduled so that there
  are breaks on either side of the start and end of divisions. This means that there will
  be breaks in between games as there will be only one division present in the gym.
  Teams can agree to start games when they are ready to go, which means they can
  take time in between for snacks and break.
- For teams scheduled with only 2 games back to back, games will start on time.
- Schedule can be <u>found on our website here</u> and then choosing the location and then weekend. All games and scores will be updated via Tourney Machine.

# CONTAINING EXPOSURE & SPREAD, SHOULD A POSITIVE CASE BE IDENTIFIED

- All participants are obligated to report any positive Covid-19 test results to their coach, who is obligated to contact Hoop Dreams Nation immediately.
- Should someone within a specific division test positive (either present in the gym, or immediate family member of someone who was present), then all those who had direct contact will be asked to quarantine.
- All tournament participants will be notified via email, regardless of direct exposure or not, in the spirit of transparency. You will not be left wondering.
- We will share the information collected on the Waiver, Policies, and Contact Tracing Form with the appropriate health departments.
- Your county health department will contact you with instructions if you are determined to be a close, direct contact of the positive case.
