



COVID-19 UPDATE
INTERIM LARGE EVENT POLICY UPDATE

The interim operating procedures and policies that have been put in place for large events at the Evergreen Sportsplex (ESC) during Phase 3 are guided by health and safety recommendations from federal, state, and local authorities. Masks/face coverings are required at ESC for this event unless otherwise specified by ESC Management. Athletes and coaches are not required to wear masks while they are on the field. We will continue with our enhanced cleaning measures & social distancing policies as recommended by the CDC.

All organizations that use the Evergreen Sportsplex will be required to adhere to specific requirements during Phase 3. These requirements, along with the tournament organizer's safety procedures must be shared with all clubs/teams/organizations prior to their participation in any scheduled activity at the Evergreen Sportsplex.

1. SPECTATOR POLICY: Spectators will be permitted at this event. All spectators must check-in at one of two (2) designated check-in locations at the Evergreen Sportsplex. Prior to gaining entry all spectators are required to have their temperature taken, will be given a spectator wristband, and will be reminded that masks are mandatory while at the Evergreen Sportsplex for the duration of this event. It is recommended that when eating or drinking that a minimum of 6 feet of distance should be maintained between all non-household members when practicable.

2. TENTS: Tents will be permitted at the facility for this event. Specific tent locations throughout the property have been pre-determined by management at the Evergreen Sportsplex and tournament organizers. If you plan on setting up a tent you must tell Evergreen staff at check-in. They will direct you to a designated area where you will be permitted to set-up your tents. Masks are **REQUIRED** to be worn on the property unless eating or drinking. Team tents must be distanced from other team tents by minimum of 10 feet.

3. ATHLETE WAIVERS: Event organizers are responsible for distributing & collecting waivers from each player and coach prior to their first use of the Evergreen Sportsplex during Phase 3. For players under the age of eighteen (18), a parent or legal guardian must sign the waiver.

4. QUESTIONAIRES: Everyone must verbally answer before every use of the Evergreen Sportsplex. Individuals under the age of eighteen (18), must have a parent or legal guardian verify the answers to the questionnaire.

- Have you, or any member of your household been exposed to someone known to have been diagnosed with Covid-19 in the last fourteen (14) days?
- Do you, or any member of your household have a current diagnosis of Covid-19?

5. TEMPERATURE CHECK: Every individual will be temperature checked prior to gaining entry to the Evergreen Sportsplex. This includes players, coaches, staff, officials, and spectators.

6. DENIAL OF ENTRY: Entry will be denied for any of the following reasons:

- Any temperature reading of 100.4 or higher
- Any "YES" answer to the questionnaire questions
- If there is no signed waiver by an athlete's parent or legal guardian

Anyone who is denied entry due to a temperature reading of 100.4 or higher or a “YES” answer to a pre-entry question must get a doctor’s release prior to being able to gain entry to the Evergreen Sportsplex. Any player with an actively diagnosed case of COVID-19 will not be allowed access to the Evergreen Sportsplex under any circumstances.

7. SOCIAL DISTANCING: Everyone is responsible for following social distancing requirements for the entire period that they are at the Evergreen Sportsplex. During Phase 3 there will be a limit of 250 people (combined players, coaches, support personnel, and spectators) per field. It is recommended that while eating and drinking a minimum of 6 feet of distance is maintained between all non-household members.

8. PHASE 3 BATHROOM POLICY: Certain sinks, stalls and urinals may be “closed off” to allow for social distancing. Anyone using the bathrooms will be required to wear a face covering.

9. PERSONAL PROTECTIVE EQUIPMENT (PPE): All spectators and officials are required to wear face-covering/masks while at the Evergreen Sportsplex for this event. Athletes, referees, and coaches do not have to wear masks while on the field but will be required to wear face coverings/masks anytime they are not on the field.

10. SPACING OF PLAYER EQUIPMENT: Player equipment and possessions left on the sidelines should be spaced to maintain at least six (6) foot social distancing.

11. LIMIT TEAM-SHARED EQUIPMENT: The use of team shared equipment should be limited whenever possible and should be sanitized after each use.

12. NO HANDSHAKES/CELEBRATIONS: Players and coaches should refrain from handshakes, high fives, fist/elbow bumps, chest bumps, group celebrations, etc.

13. WATER: Athletes and coaches should bring their own water bottles to all team activities to help to reduce transmission risk. The Evergreen Sportsplex will not be providing drinking water on the fields during Phase 3. Beverages are available for purchase at ResQ Grille, located on the mid-level of the pavilion.
