



BIGGER THAN BASKETBALL 2021 COVID-19 WAIVER

The undersigned acknowledges that novel coronavirus ("COVID-19") infections have been confirmed throughout the United States, including several cases in South Carolina. In accordance with the most recent guidance and protocols issues by the World Health Organization (WHO), the Centers of Disease Control and Prevention (CDC) and South Carolina Department of Health and Environmental Control (SCDHEC), for slowing the transmission of COVID-19, the undersigned hereby agrees, represents and warrants that the undersigned shall not visit or utilize the facilities, services and programs of Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball") within 10 days after returning from highly impacted areas subject to CDC Level 3 Travel Health Notice, exposure to any person returning from areas subject to CDC Level 3 Travel Health Notice or exposure to any person who has a suspected or confirmed case of COVID-19. The undersigned hereby agrees, represents and warrants that the undersigned shall not visit or utilize facilities, services or programs of Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball") if he or she experiences symptoms of COVID-19, including, without limitation, fever, cough or shortness of breath, or has a suspected or diagnosed/ co of COVID-19. The undersigned agrees to notify Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball") immediately if he or she believes that any of the foregoing access/use restrictions may apply. Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball") has taken certain steps to implement recommended guidance and protocols issued by the Public Health Agencies for slowing the transmission of COVID-19, including, without limitation, the access/use restrictions set forth above. The undersigned acknowledges and agrees that Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball") may revise its procedures at any time based on updated recommended guidance and protocols issued by the Public Health Agencies and further agrees to comply with Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball")'s revised procedures prior to utilizing the facilities, services and programs of Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball"). The undersigned fully understands and appreciates both the known and potential dangers of utilizing the facilities, services, and programs of Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball") and acknowledges that use thereof by the undersigned may, despite Carolina Cavaliers (DBA "BTB" or "Bigger than Basketball")'s reasonable efforts to mitigate such dangers, result in exposure to COVID-19, which could result in quarantine requirements, serious illness, disability, and/or death.

BIGGER THAN BASKETBALL COVID-19 PROTOCOLS 2021 SEASON

1. Participants must have a signed COVID-19 waiver.
2. Face masks must be worn at all times inside the facility by spectators. Coaches, staff, and players are required to wear a mask anytime they are not on the playing court. All masks must fully cover the mouth and nose.
3. Coaches, trainers, and participants will have access to hand sanitizer.
4. Players need to bring their own water bottles and/or drinks. Drinks are not permitted to be shared among players and/or staff. Water fountains are only available to refill bottles.
5. Participants should avoid contact with others (handshakes, hugs, etc.) that are not necessary to compete and practice.
6. All game balls will be sanitized by referee, event host or facility manager and event host will provide sanitizing wipes.
7. Spectators are expected to appropriately socially distance in the stands and may be asked to vacate the facility when his/her child's team is not on the court to allow for social distancing.
8. All players and BTB staff are required to have their temperature taken upon entrance to events. Persons with a temperature of 100.4 or higher will not be permitted to enter the facility.
9. Anyone entering the facility who has recently experienced COVID-19 symptoms, knowingly been exposed to a positive case of COVID-19, or tested positive for COVID-19 will not be permitted to enter the facility. Per public health recommendations, any person exposed to COVID-19 or who contracts a confirmed case will not be permitted to participate in BTB activities until 10 days have passed since exposure/symptoms began and/or a negative COVID test is provided. Approval to return is based on coach and director's approval.
10. Attendees of different events and programs are expected to appropriately socially distance before, during, and after their respective event and/or program in an attempt to minimize contact with others. All athletes must follow outside event & facility COVID-19 protocols including waivers, temperature checks, and any related guidelines.
